### **ReadingPals (2017-18 school year)**

ReadingPals is a school-based mentoring program that matches 200 volunteers who read to four year old per-kindergarten students to help build strong per-literacy skills necessary for kindergarten success. Volunteers are needed to serve one hour per week, or 25 hours total, with a student from one of our volunteer sites during the 2017-18 school year.

### **Cram the Van (July – August)**

Cram the Van, the school-district approved supply drive, provides students with the tools necessary to succeed and reduces the stress on teachers who spend their own money to supplement materials in the classroom. In Escambia County, 62% of our students are eligible for free or reduced lunches. By combing resources, our community can show a united effort as it supports our schools to ensure a bright tomorrow.

### **Day of Caring (October 13, 2017)**

Day of Caring is the largest single day of volunteering in Northwest Florida. The 2016 Day of Caring coordinated 1,250 volunteers to successfully complete 87 projects at 58 agencies and schools in Escambia County. Together, Day of Caring volunteers donated almost 7,000 hours that provided local nonprofits and schools an estimated \$162,000 in free labor, impacting a total of 70,000 people in our community.

### **Community Investment (February – April)**

Through United Way of Escambia County's Community Investment process, United Way donors come together to make recommendations on how undesignated donations should be invested in non-profit programs that serve in our community. Community Investment volunteers review applications for funding, tour the agencies requesting funds, and recommend funding decisions.

### **Loaned Executive Leadership Program (February – January)**

Loaned Executives (LEs) serve as leaders by advocating and supporting the United Way Workplace Campaign which raises over \$2 million annually to support local nonprofit programs. LEs will manage a small portfolio of assigned organizations with established relationships and assist organizations with planning a successful campaign. LEs lend their time and talents to participate on the Community Investment Committee, manage Workplace Campaigns and attend leadership seminars.

### **RSVP (year-round)**

The Retired and Senior Volunteer Program (RSVP) is a free, federal program to support volunteers 55 and older. United Way partners with nonprofits within Escambia County to help guide you to a volunteer opportunity that matches your skills, experience, and lifestyle with community need.
